STEP BY STEP PROCESS

- Research & connection
- Formation new company or establish branch
- Obtain all needful licence & permits
- Open business bank account
- Transfer business capital
- Hire an accountant, manager, employees
- Start paying tax and social contribution
- Prepare solid business Plan
- Demonstrate investment budget
- Prepare visa application



STEP-1

Research & Connection

Demonstrate your research with the Portuguese market simultaneously prove your association with licensing/permits authorities. Establishment place of your projected business as the physical or virtual connection with Portuguese territory. Research on your target audience as well as business associates.

STEP-2

Company or Branch Establishment

Establish a new company or open a branch office of an overseas company or register as a freelancer or shareholding of an existing Portuguese company.

Additionally, open offshore or onshore legal standing besides above.

STEP-3

Licence & Permits

Obtain necessary license & permits through your business needs from competent authorities of Portugal. Define proposed business activities in the certification of registration.

STEP-4

Business bank account

To begin banking transactions among you and your business associates or clients, you should have a company bank account in Portugal. It is not only for trade; the tax authorities also require it.

STEP-5

Capital Transfer

Must transfer an initial capital amount to an individual or company bank account in Portugal to meet direct expenses.

STEP-6

Services Contracts & Hiring

Prove service engagement between your business and services provider or receiver as such expert, lawyer, accountant, representatives, and vendors must be issued a warrant of basic salary or payment.



STEP-7

Tax & Social Contributions

Pay applicable taxes & social contribution to the state government for personal as well as representatives. Taxes & social contribution subject to activities of your profession in Portuguese territory.

STEP-8

Solid Business Plan

Must have a solid & motivated business plan which business will be to implement in the Portuguese market. Also, demonstrate how to control the targeted market along with benefits for local public and government.

STEP-9

DEMONSTRATE INVESTMENT BUDGET

Apart from capital, must demonstrate the projected entire budget of investment in the financial institution or guarantee of invested funds to rise in Portugal.

- Bank statement
- Credit Guarantee

STEP-10

Prepare Visa Application

Compilation of all compliances applicant must fill all mandatory field of the Visa application correctly with concerned reference of documents.

Visa application Submission

You are compiling the visa application for submission at the Portuguese consulate in your home or resident country. Once the request completed, the consulate will forward the application to the Portuguese immigration authority (SEF). May the Portuguese consulate ask for additional documents or call for an interview.

STEP-12

Visa application decision

SEF analyses your application for the final decision among the communication tax & social security or other certified bureaus in Portugal. Also, overview the business idea, which described with your visa application. In practices analyses, the period will take 90 to 120 days.

STEP-13

Visa stamping

After getting a favourable decision from SEF, the Portuguese consulate will stamp the visa on your passport for the validity of 120 days dual-entry type D-2 visa.

TIME TO TRAVEL

STEP-14

TRAVEL & REPORT TO SEF FOR BIOMETRIC

Applicant obliged to report Portugal immigration authority (SEF) within the validity of visa for the biometrics (Fingerprint).

STEP-15

COLLECT RESIDENCE CARD

The residence card will deliver to your Portuguese home address by post, which will be valid for the next two years.



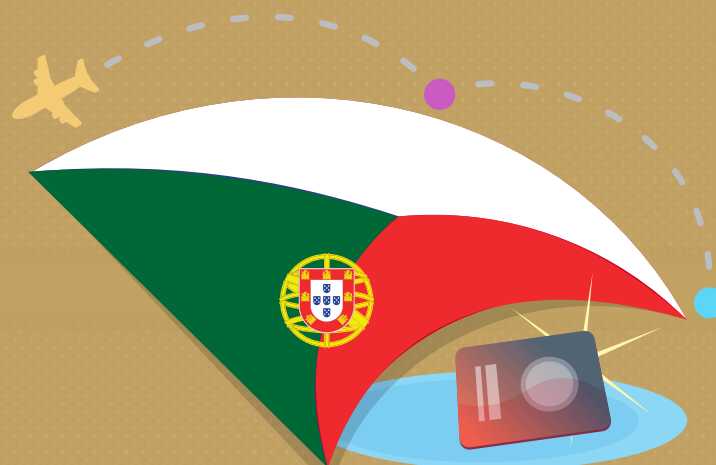
STEP-16

FAMILY REUNIFICATION

Once the primary applicant holds a Portuguese residency card right to call family members under family reunification.
